Terms of Service and Use

1. Your Acceptance

BY USING AND/OR VISITING THE CLICK CLICK EXPOSE WEBSITE (collectively known as "CCE WEBSITES,") including all Content available through our family of websites, podcasts and video sharing websites administered by and/or hosted by Click Click Expose, including www.clickclickexpose.com, www.clickclickexposelive.com, the CCE Sports Network domain at www.ccesportsnetwork.com, the Planet Q.tv domain at www.planetq.tv, the Click Click Expose You Tube channel, the Click Expose Daily Motion channel, The Click Click Expose Gay Podcast Network hosted by iTunes, all live streaming services (including but not limited to the pay per view services and free live streaming services, and/or any video or audio portals that Click Click Expose uses, namely "BrightCove, YouTube, Live365, DailyMotion, Metacafe, Blip.TV, Veoh, Vimeo, Google Video and MakeAVoice server"), YOU SIGNIFY YOUR ASSENT TO BOTH THESE TERMS AND CONDITIONS (the "Terms of Service"), AND WHICH ARE INCORPORATED HEREIN BY REFERENCE.
